

## Access Networks Big Green Egg® Promotion

### OFFICIAL RULES AND CONDITIONS OF PROMOTION

NO PURCHASE NECESSARY. PURCHASE OR ACCEPTANCE OF  
A PRODUCT OFFER WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1. DESCRIPTION.** Access Networks will conduct a promotional contest in which an active Snap One or Access Networks partner will gain entries to win a Big Green Egg® by earning tickets (as outlined in section 5) that can result in the winning of the prize by randomized drawing of all ticket entries.

This is a one-time promotion beginning August 1, 2023 at 12:00AM PT and ending September 29, 2023 at 11:59PM PT.

- 2. SPONSOR.** Access Networks, A Snap One Brand - 28482 Constellation Rd., Valencia, CA 91355 (the "Sponsor"). Sponsor reserves the right to modify, suspend, extend, or cancel the Promotions (with or without notice) at any time in Sponsor's sole discretion and may, but is not required to, substitute another promotion in its place. Sponsor further reserves the right to amend or change these Official Rules and Conditions of Entry (the "Official Rules") at any time, in Sponsor's sole discretion.

- 3. ELIGIBILITY.** This Promotion is open only to legal residents of the fifty United States and the District of Columbia who are active dealers in good standing of Access Networks or Snap One during the Promotion Period. The term "dealer" or "partner" is defined as one location of an organization. If multiple locations of an organization exist, each location will be treated as its own dealer. The Promotion is subject to applicable federal, state and local laws and regulations and are void wherever prohibited or restricted by law. Entrants who are residents in places where the Promotions are prohibited by local law will be deemed ineligible and will not be eligible for the prize. Employees, officers, directors, agents, representatives, and their immediate family members (spouses and siblings, parents and children and their spouses) and household members (whether related or not) of the Sponsor (Access Networks or Snap One) are not eligible to participate in the Promotion. Magnolia dealers are not eligible for this promotion.

- 4. AGREEMENT TO THE OFFICIAL RULES.** By entering the Promotion, you fully and unconditionally agree to be bound by and accept all terms of these Official Rules and the decisions of Sponsor (including decisions with respect to the selection of a winner and the interpretation of these Official Rules), which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

## 5. HOW TO ENTER. Entries can be made in two ways:

### A. Automatic Entry Via an Access Point Purchase

Purchase an Access Networks branded access point(s) from Access Networks Partner Portal ([My.AccessNetworks.com](https://my.accessnetworks.com)), the Snap One Partner Portal ([SnapAV.com](https://snapav.com)), or in a physical Snap One Partner Store location listed [here](#). Each access point purchased gains an automatic ticket or tickets to entry based on the purchase criteria below:

- a. Purchase of an Access Point with no service included: 1 ticket per access point
- b. Purchase of an Access Point utilizing Basic Configuration Services: 2 tickets per access point
- c. Purchase of an ARCC controlled Access Point: 3 tickets per access point
  - a. This includes any Access Points purchased in a Core Network utilizing ARCC as well.

Tickets will be automatically awarded once the access point(s) is paid for. Your purchase transaction must be received by 11:59pm PT on September 29, 2023 to be eligible to receive tickets.

### B. No Purchase Required Mail-In Entry Method

To be awarded (5) ticket entries without making a purchase, write in your own handwriting on a 3"x 5" piece of paper your complete first and last name, street address, city, state, zip code, date of birth (mm/dd/yyyy), valid e-mail address, and daytime telephone number including area code. Then, on the opposite side of your entry, in at least 30 words complete the prompt: "I would choose to use Access Networks access points for my project because...".

Mail your entry in a #10 business-size envelope with postage affixed to: **Access Networks, 28482 Constellation Rd., Valencia, CA 91355 USA**. Your outer-mailing envelope must include a valid return address, which includes a complete first and last name. Mailed entries received without a verifiable and legible return address will be deemed incomplete and invalid. Limit one entry per outer-mailing envelope. Bulk shipments (multiple entries in one shipping package) will not be accepted. Mail-in entry, including outer-mailing envelope, must be handwritten. No mechanically reproduced entries or metered mail permitted. Statements contained in mail-in entries will not be judged but must be unique in nature. Statements must not in any way reflect negatively upon Sponsor, the Promotion or any other person or entity. Entries that are postmarked starting August 1, 2023 and received by September 29, 2023 will be eligible for the drawing. Each mail-in entry will count as five (5) ticket entries, provided that the mail-in entry complies with the above requirements.

Mail-in entries that are not in the proper format specified above, that are illegible, inaccurate, incomplete, or reproduced via photocopier or otherwise will be considered void. Proof of submission does not constitute proof of receipt. The Sponsor is not responsible for lost, late, illegible, mutilated, misdirected, postage-due entries or entries

The random drawing will be conducted after September 29, 2023 and the winner will be chosen randomly from among all eligible ticket entries. The odds of winning a prize depends on the number of eligible ticket entries gained by the proper entry ways outline in section 5.

NOTE: Prize will be awarded to the overall company, not to a specific person. Distribution after awarding is up to the company digression after receiving the Big Green Egg®.

The winning company will be contacted via email and/or telephone number that is on file with Access Networks or Snap One. If the winner does not acknowledge, respond, or answer to the prize win notification within 2 business days, another winner will be selected at random. Winners subject to fill out any required paperwork before receiving prize. Failure to fill out required paperwork will result in winning company being deemed disqualified.

**7. PRIZE AND PRIZE DESCRIPTION.** The eligible Entrant selected by random drawing will receive a Large Big Green Egg® in an intEGGrated Nest+Handler with Mates Package. A dealer account must be active and in good standing at time of access point purchase and promotional drawing/result. Program can end at any time, at the discretion of Sponsor.
